This announcement is supported by a continuing education record.

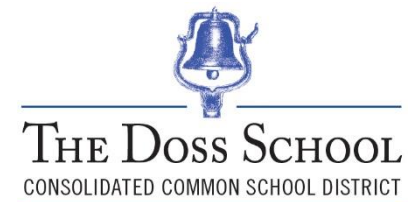
